## VILLAGE OF NELSON REGULAR MEETING - MINUTES

**MAY 12, 2021 @ 7:00pm**

The Village of Nelson met in regular session on Wednesday, May 12, 2021 at 7:00pm with President Brian Glass presiding. Roll call- All present. Mike made a motion to approve the April minutes with a second from Kevin. Motion carried.

Thrive park/house property donation was discussed by the board with Gary Christopherson present. Randy made a motion to accept Gary's donation to the village upon transfer and a second by Mike. Motion carried. Paper work was signed by Brian Glass.

New computers for Tina-treasurer and Cindy-Clerk were discussed. Tina has an estimate for two laptops with set up fees added. Randy made a motion with a second by Becca to approve the purchase of the laptops and set up. Motion carried.

New Business: Beth Blee has asked if the village would fix the fence between Beth's Cafe and the Twin Bluff Bar. Bruce will look at the fence to see if it can be straightened out. Bob Bauer has asked about a tree in the village right away that has branches leaning over his garage. Bruce will look into getting the tree trimmed or taken down. Kevin made a motion with a second by Mike to approve the mowing contract for the cemetery from J&J Lawn Care LLC. Motion carried.

Becca will order bases for the ball field in Castleberg Park. Bruce will remove the old shed in the park and will be purchasing a new one soon. The bleachers also need to be cleaned and painted. Bruce has ordered black top for Markey Bluff Road and Christopherson Rd which has already been approved by the board.
